Technical Capability/Experience) is amended to three (3) years of experience. See below for revised language. This amendment also updates the applicable DOL Wage Determination to DOL WD 2015-5017 Revision 34, dated 8/12/2026. - Experience MUST be in a clinical/hospital environment of similar size and scope which consists of a workforce of at least twenty (20) janitorial/environmental services personnel operating concurrently across multiple shifts on a 24/7 or near continuous basis and involving the use of infection prevention/aseptic cleaning practices and handling of medical waste. Offeror shall provide information which supports this requirement which shall include, at a minimum: number of staff provided on previous contracts, type of work performed, and name of facility.
